BRIDGES at Lake Park Hosts Informative Q&A with Lake Park Sheriff's Dept.

BRIDGES at Lake Park recently held an insightful and engaging Q&A presentation in collaboration with the Lake Park Sheriff's Department. The event provided a valuable opportunity for parents to voice their concerns and ask important questions directly to local law enforcement.

One of the key topics covered was an overview of the 4th Amendment rights under the United States Constitution. Parents received clear and essential information about their legal rights regarding home searches. Officers explained that, unless they possess a warrant signed by a judge or magistrate — which must include the individual's name and be presented, even slid under the door if necessary — they cannot legally enter a residence without permission.

The session fostered an open dialogue between families and law enforcement, promoting understanding and trust within the community. BRIDGES at Lake Park remains committed to empowering parents and ensuring they have access to crucial knowledge that helps keep their families safe and informed.
